**Invitation to Expression of Interest  
for the Provision of Services to Operate a District Health Centre and  
Outreach Service for Secondary School Student Wellness**

The Health Bureau (“HHB”) intends to engage and solicit market information / proposal for an operator (the “Operator”) to provide services to operate a District Health Centre (“DHC”) and Outreach Service for Secondary School Student Wellness, under a non-profit making funding model. An outline brief covering the purpose, background, objectives, service scope, and other requirements are attached in Annex A (Outline brief) for your reference.

If you are interested in providing such services, please submit your expression of interest (“EOI”) by returning the Reply Slip and provide the required information in accordance with the guidelines in Annex B (Return form).

Since this expression of interest exercise (“the exercise”) only seeks a general expression of interest which will not constitute or imply agreement between your organisation and the Government of the Hong Kong Special Administrative Region, it is not necessary for you to provide detailed proposals at this stage.

Your expression of interest with a subject title marked as “Expression of Interest for the Provision of Services to Operate a District Health Centre and Outreach Service for Secondary School Student Wellness” should be submitted by email to [dhceoi@healthbureau.gov.hk](mailto:dhceoi@healthbureau.gov.hk) **no later than 12:00 noon on 23 April 2026 (Thursday) of Hong Kong time (Closing Date).**

Any submission after the above Closing Date and time shall not be considered.

Please note that this EOI is meant for collecting information only and should not be construed as the Government's commitment to order. Any purchase will be subject to tender and the information provided in the Annex A (Outline brief) and Annex B (Return form) will be subject to change. In submitting information for this EOI, organisations acknowledge that the Government shall not be liable for any cost or expense so incurred by them. All costs associated with the preparation of the submissions are to be borne by the organisations. Submissions received will be treated in strict confidence.
